Issue to date outlined. Representatives spoke to the issue.

Agree that they did not count votes against.

Moderation of the discord separate from the Committee; only committee member active was the President. Manus, when shown the problematic content, had the content taken down. Committee did not encourage any unlawful activity. However, agree that they did not create a safe environment online.

The matter of sexual content was dealt with, the individual banned, then let back in due to mental health concerns. The individual left anyway.

Readmission of D, a few of the Committee members met and the President proposed readmitting D. Rest of the Committee rejected this proposal. Joshua and Mohamed did not understand why D was banned, and when they did, he was not readmitted. D attended the SGM abruptly, Exec did not know what to do. D wanted to discuss how he was defamed. Exec told him it was about the Pres, not him. He was forced to stop.

The event at which the underage person was drinking was not an "official" event. Concerned that they are avoiding accountability.

Club events advertised via social media, and on the Discord.

The sexual content material was posted, shortly after screenshots were taken, person banned etc. around Sept 10.

Exec present did not vote for the motions, so counted against. Exec members had various motivations for not voting for the motions. Felt indefinite bans were too much. By abstaining it implicitly condones his behaviour. No one in the Committee voted for the motions.

Drinking prohibited in their tenure.

AMC Committee believed he should have been sanctioned, disagreed on how long.
