Seamus explains to result to the club. The club is disaffiliated and the one executive is barred.

Fiona clarifies that the one executive membership should have not led the club to this. The exec asks why and Fiona clarified the ex-treasurer was responsible for finances.

Alex explains what happened in camera. Alex apologises to the club about the last meeting as it was heated. Alex clarifies that the discussion's main outcome was that the discipline was amended to remove 7.1.c, the committee agrees the club did keep financial records and the main issue was not transacting through the club bank account. There was also a lot of discussion on which aspects of the petitions were relevant. All the petitions were made so the committee has options to vote on based on club correspondence.

Fiona clarifies the committee are not accusing the club of misappropriating funds but there are standards for how a treasurer should manage funds. It is not intended to be a personal stain forever. He thinks it's unfair, so how can he appeal. Fiona clarifies the committee is the decision-making body. An appeal for this process just doesn't exist. Changhao just wants to say that he made mistakes mismanaging the funds, but the club made the decision together and were aware. He feels this is a personal offence and money being transferred out of the bank account is for two execs to do. He thinks it is because he is the only existing exec from the previous committee.

Fiona says he is not wrong because he is the last man standing, if the outgoing committee were here, they could be held accountable. There is nothing else the committee can do at this point.

Max asks if the club has a preexisting Discord server. The Committee is concerned as they are familiar with this space, that people promote sexual roleplay. People can currently mention the club in the server. Josh's opinion has changed since last meeting and is concerned on the demographics ground – clubs that already exist. The measures are too strong and asking too much of the club. Meiqi doesn't think there is an equal way of risk and reward and will require faith that future committees will act appropriately. This club can't completely remove themselves.

Josh thinks the Queer Department or the Animanga club could cover this.

Max notes that online spaces that the club promotes sexual discussions 4.2.b.11. Fiona says this exists in the University policy.

Ronglin notes that this could be added to the constitution to deal with this. Max says Sexpression's focus is on sexual wellbeing. You do not rock up to that club expecting to consume pornographic material. Max notes a harmful situation he thinks could easily occur.

Max says the main things are high risk and online. Josh thinks the club has done a lot of panning to protect the community, but the high risk is still there.

Hope For Life

Alyssa came to provide advice on the matter. Max's understanding of the appeal is that it is based on women's rights and discrimination. It is anti-constitutional and promotes discrimination against women. Alex notes the important thing is we are not preventing their freedom of speech and they can exist, we are just managing their affiliation with UMSU. It is discussed how they are using an argument about laws but their aim is campaigning against laws. Josh doesn't think they should be a club as he doesn't think they would be a good club, as they are not serving in the interest of the student body.

Alyssa is not a lawyer so she can't provide legal advice. She found it unclear what their point was and their logic. Alyssa thinks the C&S committee decision was logical and legislation is always the case in human rights – but there can be multiple rights at play. She advises that the staff and OBs can go to the legal team and get some advice depending on the comfort level. It is pointed out that the club has misinterpreted the grounds for rejection and has made claims based on the law which would need legal advice.

The committee is not talking about the militaristic aspect of the clause which the club focused on. The club advocating against women's right and healthcare is sexist discrimination, not militaristic. Since one demographic is applied to in this instance, it is sexist discrimination. The misinterpretation of the clause has caused half of the problems with the appeal.

The club needs clarity about the misunderstandings. There is a lot more funding and support for right wing groups and trying to start turning the tide to repress women.
