### 4. Matters carried over from the Previous Meeting

### 4.1. Income Tax

Clubs have income tax self-assessment obligations, some are not exempt and already pay taxes, some are exempt in various categories.

The changes to the income tax process apply to clubs that self-assess as Exempt, but that have an ABN; in which they will have to report their exemption to the ATO (via a MyGov account).

UMSU CFO is reviewing the Tax Self-Assessment forms and they will be updated accordingly.

UMSU Legal will undertake an ABN search (including GST registration)

Recommend that we also undertake a 100% audit of clubs tax management, asking them to report their statuses (income tax & GST) and ABNs

Nothing has changed for clubs that do not have an ABN

Committee suggests that we may need to look at Training/Assistance for club execs.

The change applies to the 2023-24 Tax Year, with October reporting – need to warn clubs to get their tax stuff in order.

### 5.2. Bystander Intervention Training

SHRC running make ups for non-compliant clubs.

Report is impressive, there are several recommendations outlined:

- Workshops only during Semester
- 20% outside of business hours
- Reduce length of workshops
- Change compliance requirements for smaller clubs
- Zoom sessions ONLY if club give a reason for not being able to attend in-person
- Create 2 separate workshops (Bystander Intervention/Responding to Disclosures)
- Add Online pre-training
- Review use of videos in bystander
- Review drafted UniMelb Respect Modules and adjust workshop content
- Develop public education campaign
