Fiona summarised the issue, and the SGM conduct problems. The President had been moderating the Discord and permitted and engaged in several kinds of

problematic behaviour, for which evidence has been provided. He had also planned to readmit a problematic member (D) who had previously been asked and had agreed to leave the club.

The President resigned before the SGM, and the meeting considered two motions (to ban the President from being a committee member for 12 months, and to expel him from the club). The motions were put to the vote and only the yes votes were counted. There was not a call for Against vote and Abstentions, with all non-Yes voted counted as Against. The motions were Lost.

At the SGM two problem speakers were permitted to take the floor. One defended the use of "Retard" as a word that has legitimate meaning in medicine and aeronautics, and repeatedly used the word. The second was introduced as a "mystery guest" and was revealed to be D, who proceeded to defend their behaviour, although that was not the purpose of the SGM.

The AMC representatives also advised the C&S Committee that the AMC Committee had met to discuss the readmission of D and had allegedly agreed to admit him but not report it to C&S.

They also reported that the SGM was disrespectful, with a member being denied the opportunity to ask a question.

The C&S Committee discussed applicable disciplinary powers.

ACTION: Introduce C&S Regulation for C&S Committee to remove/ban executives, including a "no-fault" stand-down.
