Club has been offering a multi-year membership which is not consistent with the Regulations. C&S staff have worked with them to create free renewals in the website for those members, but they still have many members that have not come across. They gave Notice via Faculty list, not the website, there could be members in the website that did not get Notice.

Leon questioned if this was a reflection of the website issues we have previously seen, but it was explained that they were all 2022 issues, and we should not be seeing this in 2023, when all memberships were supposed to be sold via the website.

The club explained that the President and Treasurer had quit, and did not give handover to rest of Committee.
