Main concerns, appointment of RO, counting of votes and allowing members in.

Luv explains there was not a motion. Luv says Tarish challenged the motion. The reason there was no motion was because this was the case in previous year's AGM.

Luv says this was stated in the notice, not that it happened in the meeting.

Josh asks about people who were prevented from voting.

Doris arrived at 9:36am

Luv says the members were compared against the membership list. Luv says members were called back in and asked to stand on one side of the room.

Tarish says some attendees were asked to leave at the advertised start time, not the meeting nstart time. There was definitely quorum. Reg 5.2c. is read out. RO can deem what the appropriate voting list it.

Luv clarifies the motion that was passed at the committee meeting about the digital membership list that was provided to him by the club.

Tarish asks when the membership report was generated. Pranav said it was generated at 12:30pm.

Alex asks if there's anything saying the memberships close at the AGM.

Tarish says the RO does have discretion about who is a member and who isn't.

Josh asks how tight the votes were.

Doris asked if people voted twice.

The method that was used was show of hands. Online voting has room for technical errors. Luuv doesn't think Opavote is not good and it is a paid service.

Because there was 150 people, to avoid double counting he asked members to show their hands and then called the number out loud as he was voting and then people put their hand down once he called them out and everyone saw this as it was not a secret vote. And someone put their hand down without him calling them.

Tarish clarifies he was not looking at the voting so he can't speak to it and suggests an option would be to request CCTV.

Tarish confirm he saw it was not a secret ballot. A bunch of people standing in the room and raising hands and luv was asking people to put their hands down once voted.

Luv says a member was following him closely throughout the votes.

Tarish says there's insufficient evidence from the complaint to prove the voting was not legitimate. The RO issue is bad, but verifies the members were invited back into the room.

Luv adds that the club form that was circulated by the QR code on the srren – received 180 responses but when the meeting opened there were 160bpeople in the room. Luv feared that online attendance link could have been shared and received illegitimate responses.

Melanie tells club to use UMSU website next time to take attendance as only members can buy the tickets.
