9.1 Mid-year financial review (continued)

Motion 9.1:

Mary asked the Student Representative Coordinator (Ciara) regarding the status of Education Action Collectives for this semester. Considering low attendance (which has been an issue last year as well) and lack of campaigns, there is a strong case for not running the collectives this semester temporarily. While we are constitutionally bound to run collectives, there is no explicit policy stating its frequency (weekly, fortnightly etc).

Here are further suggestions from Ciara:

"It may be worth putting in your recommendations for 2024 that the Education Collective is planned to be held only once or twice a semester, as a forum to hear educational issues and concerns from students – a bit like a Town Hall. Running them weekly or even fortnightly seems exhausting!"

Therefore Education collectives can be suspended for this semester, with the unspent funds (\$250 each for Sept and Oct) transferred back to the Whole of Union.
