


We initially wanted to run a Clothes Swap for Winterfest, but CME has asked us to do workshop social-like activities during the UMSU Carnival on the 20th of July. The event they preferred from the list we gave was a bead-making activity, where we run three ticketed sessions of people making sustainable beaded jewellery where we explain the department and all our events and campaigns.

Costs include bulk buying the required materials and other CME expenses.

Any money not spent will be repurposed into the budget.
