10.2. Condemnation of the Labor Government's Proposed International Student Caps and Affirmation of the University of Melbourne Student Union's Support for International Students

Preamble:

The University of Melbourne Student Union (UMSU) recognises the invaluable contribution that international students make to the academic, cultural, and social fabric of our university. International students not only enhance the diversity of our student body but also contribute significantly to the local and national economy. Any policy that imposes caps on international student enrolment risks undermining these contributions and sending a damaging message of exclusion.

The Labor Government's proposed international student caps threaten to restrict access to Australian education for many prospective international students, creating barriers to entry and reducing the global standing of Australian universities. These caps may also increase financial strain on universities, forcing a reduction in available resources for all students.

UMSU stands in solidarity with our international student cohort, affirming that they are a valued part of our university community and deserve to feel welcomed and supported.

That UMSU Commits to advocating for the rights and welfare of international students, ensuring that their voices are heard in all relevant discussions and decision-making processes at the university and national levels.

10.3. Oppose Israel's war of aggression on Lebanon

Preamble:

Israel is waging war on Lebanon. IDF attacks have killed over 2000 civilians and displaced 1.2 million in just two weeks. On 17th September, the IDF exploded handheld pagers and walkie-talkies across Lebanon in a coordinated terror attack that killed 42 people (including children and medics) and injured at least 3,500. This shocking act of state terrorism was the prelude assault to the ongoing aerial bombardment of South Lebanon and the capital, Beirut. Israel has dropped US-designed 900-kg "bunker-buster" bombs on densely packed civilian areas. These bombs can penetrate 30m below ground or through 6m of concrete – dropping them on cities is banned by the Geneva Convention. On 1 October, Israel launched its ground invasion of South Lebanon to continue terrorising Lebanese civilians and occupying territory.

Israel is a highly militarised state with nuclear weapons, backed by billions in aid and arms from the world's superpower, the United States. After twelve months of genocide in Gaza where over 180,000 have been killed by IDF weapons or hunger and illness, Israel expanding its war and terror to a second front. The only outcome of this war will be tens of thousands more civilian deaths and millions of people forced to become refugees overnight.

In Australia, Israel's war crimes are given total impunity by the media and government. Anti-war, anti-genocide students in Australia have a responsibility to oppose these attempts to cover for this devastating war. We also have a responsibility to oppose the Australian government collaborating with the IDF and signing deals with Israeli weapons makers.

10.4. 12 months of genocide - Oppose Israel's genocide in Gaza and violent attacks in the West Bank and support the Oct 6 National Day of Action for Palestine

Preamble:

This week will commemorate one year genocide in Gaza, one year of international struggle, one year of resistance, one year of fighting for Palestine. Disturbingly, every mainstream institution in Australia has rallied closer to Israel at the twelve month mark of the genocide, as Israel begins their new offensive into Lebanon. We must continue to stridently oppose Israel's genocide.

We have watched Israel massacre innocent people while they slept in Rafah, while they sought aid and shelter in the Flour massacre, while displaced families took refuge in Al-Shifa hospital. They have targeted journalists, aid workers and doctors, they have targeted designated humanitarian safe zones, UN schools, refugee camps and hospitals. The Lancet Medical Journal estimates that over 180,000 have died in the last twelve months and an average of 23,000 Gazans are dying each month due to starvation and disease. At every single point of this atrocity, the leaders of the world have turned their backs on Palestine.

In the West Bank, illegal settlements expanded through unprecedented violence to Palestinians. In July, the International Court of Justice (ICJ) concluded that Israel's occupation of Palestinian territories violates international law and argued that the occupation should be ended "as rapidly as possible". Instead the Israeli government has announced thousands of new settlements while settlers — emboldened by the Gaza war — established new outposts without official approval. One example of settler violence in Qusra came not even 24 hours after the ICJ ruling — the settlers, using metal pipes and wooden batons, attacked Palestinian farmers tending to their lands alongside the volunteers seeking to protect them.

Israel has received unwavering support from America, Australia and other western governments in every media outlet, every politician speech, every multibillion dollar military aid package.

This week also marks fifty-two weeks of anti-war, pro-Palestine demonstrations. Tens of thousands of protestors have made their opposition to war and genocide known for months on end – a number unprecedented in Australia anti-war movements.

10.5. Student forum with West Bank activists from the Ni'lin Popular Committee

Preamble:

The Education and Environment Department will host a Week 12 student forum with three speakers from the West Bank.

Ni'lin is a West Bank town seventeen kilometres from Ramallah. The 1993 Oslo Accords designated it part of "Area C", where Palestinians live under Israeli control. Ni'lin is surrounded by the West Bank Apartheid Wall to its west, an Israeli military base to its south, two Israeli settlements—Nili and Na'ale—to the north and a settler-only road to its east.

Ni'lin made international headlines during the construction of the Apartheid Wall—a wall dividing Palestinian settlements from Israel—in 2008. In response to peaceful protests, Israeli border police shot and killed 10-year-old Ahmed Moussa, spurring on the campaign. Israel continued to respond with violence: rubber-coated steel bullets, tear gas canisters, the uprooting and burning of olive trees and even "skunk", a sewerage water designed for crowd control that causes vomiting when inhaled.

Today the violence is even worse. Since Israel's genocide in Gaza, illegal settlers have been emboldened to attack Palestinian villages more frequently.

The Ni'lin Popular Committee is an activist organisation in the West Bank. They are dedicated to grassroots campaigning against illegal Israeli settler aggression. A large part of what they do is aid including food and legal support to the local community. Its work is critical to the day-to-day survival of many Palestinians.

University of Melbourne students are clearly motivated by the Palestinian cause. Student engagement for Palestine at Parkville and Southbank this year has been phenomenal. 600 UniMelb students voted for at the student mass meeting, many attended the Gaza Solidarity Encampment and the uni walkouts for Palestine and every week UniMelb students attend the Sunday Palestine demonstrations. There is clearly vast support for the issue amongst the student body.

This is why our departments are hosting a forum to hear from Palestinians in the West Bank—some of the most heroic activists fighting apartheid and ethnic cleansing. It would be an opportunity for more student enrichment, building international links and solidarity with Palestinians from the West Bank and students in Melbourne.
