## 9.1. Student Initiative Grant (SIG) Applications

Chair spoke to the four applications received prior to Council. All have asked for the maximum amount of \$1000. Chair noted that there is \$5000 budgeted for SIG in Semester 1, therefore Council cannot accept all applications that come through. Each of the applications were discussed as follows:

## Planetary Health Workshop Series

Julian asked how many students would the proposed catering serve. Chair responded that the question is not on the form.

## Peer Mentoring Program Closing Ceremony

Chair reminded Council that the funding applicants are asking for (\$1000) is less than 10% of the event's budget. Given the size of the event budget, it doesn't fit with SIG is supposed to do, event also has other sources of funding.

## Royal Melbourne Hospital Medical Student Valedictory Dinner

Chair noted that the dinner, UMSU is asked to subsidise the dinner ticket. Requested amount is low (\$1000) relative to the entire event budget (\$15000).

## British Medical Journal Christmas Issue Writing Group

Chair reminded Council that SSAF is not for funding research, but could fund the experience within research.

Julian asked whether this application is a one off initiative. Chair responded that it has been running for a very long time.

Julian expressed concerns about the event catering costing about \$1000 per student.

Chair responded that it is up to Council to decide whether the applications are a fair spend of money. Only the first one fits the criteria for SIG – workshops and networking for students of the African diaspora, event also does not have alternative sources of funding.

The other three applications should be rejected on the following grounds:

- Grant does not have effect on actual operations of the event;
- Questionable outreach and promotion for UMSU during the event, and how many people will actually be engaged with UMSU as a result; and
- The research application in particular is beyond the nature of the grant.

Chair recommends that Council vote on each application separately, rejecting the last three.

Leon asked how much money is budgeted for SIG. Chair responded that SIG comes from the Whole of Union budget line, totalling \$10000 for the whole year, divided in 2 semesters, \$5000 each.

Leon expressed his support for the Closing Ceremony application.

Chair reminded Councillors to consider how the funding will significantly impact the operations of the event. The Closing Ceremony in particular will be getting funding from ticket sales and FBE, it is also part of the University's Peer Mentoring Program, which currently receives funding from SSAF.

# **10.4.** UMSU stands with Violet Coco and Bradley Homewood - jail climate criminals not climate activists

#### Preamble:

Extinction rebellion activists Violet Coco and Bradley Homewood have been hit with two month long prison sentences for protesting the climate crisis. Earlier this month they hired a truck and parked it across three lanes on the West Gate bridge, unfurling a banner which read "DECLARE A CLIMATE EMERGENCY."

They were arrested for "public nuisance." Yet just across the bridge, in Southbank, police blocked many more lanes of traffic while escorting a cavalcade of climate criminals to the Melbourne Convention and Exhibition Centre. There they met for a special summit of ASEAN, the Association of South-East Asian Nations. While the West Gate protesters were remanded in custody, heads of state and mining billionaires were wining and dining, wheeling and dealing at the summit's CEO lunch.

Australia is the third largest exporter of fossil fuels globally. The leading cause of climate change is fossil fuel emissions. This makes our own leaders some of the biggest criminals on the planet. But they get to walk free while jailing those who protest against the destruction of our planet for profit. In prosecuting Violet and Bradley, the Australian government is also curtailing the basic democratic right to protest, which includes acts of civil disobedience in the form of strikes, blockades, marches and occupations. Student unions have historically been at the forefront of movements demanding democratic rights - From the fight to defend free speech on campus to mobilising in favour of marriage equality.

#### Platform:

- That UMSU supports the democratic right to protest, including acts of civil disobedience in the form of strikes, blockades, marches and occupations.
- That UMSU affirms its support for climate activists and condemns state repression.
- That UMSU demands all charges against Violet and Bradley be dropped immediately.

#### Action:

That UMSU elected Student Representatives take a solidarity photo in this council meeting.

Bella spoke to her moving rights.

There was extensive discussion over the motion.

#### Yash proposed an amendment:

#### **Proposed Amendment:**

Amend the motion to remove the action.

Yash invited to speak to the amendment, he did not exercise his right of reply.

Raphael waived speaking rights as the seconder, Paterson Laws spoke to the motion instead.

Jaan spoke against the amendment. Taking solidarity photo is ordinary. Motion is significant because raises significant issues. Student union should extend their solidarity.

There were more discussions over the motion.

Raphael invited Yash to speak, Yash waived speaking rights. Raphael expressed that fighting for democratic rights is more important than discussing whether to approve a grant for a boat party (Closing Ceremony SIG application). Student unions should take political issues seriously, and pick a side.

Stefan questioned what the motion will do to deliver for students like him.

#### 10.5. UMSU condemns all nuclear power

#### Preamble:

Peter Dutton and the Liberal National Party have recently proposed the creation of nuclear energy sources in Australia. They have officially added to their party platform a plan to build small and large scale nuclear reactors on retired coal-fired power stations near towns such as Anglesea and the Latrobe Valley.

Nuclear power has been banned in Australia since 1983 and now Dutton is calling to overturn this ban and build nuclear power as a renewable energy alternative to coal. This would be disastrous. Nuclear power is the most dangerous energy source in the world and a necessary component for weapons construction - the seven countries with the largest nuclear weapons stockpiles also have serious networks of nuclear power and this is not a coincidence.

As scientists writing in a 1946 US State Department report said, "The development of atomic energy for peaceful purposes and the development of atomic energy for bombs are in much of their course interchangeable and interdependent". This remains true today.

And then there is the problem of nuclear waste, the indestructible radioactive byproduct of nuclear power. The nuclear submarine deal AUKUS has again raised the question of where this radioactive waste will be dumped —and inevitably, it is Indigenous land that is being considered.

Australia also already contributes a crucial step in the creation of nuclear power the mining of our massive uranium stores. However, it is illegal to mine uranium in most states and territories besides the NT and WA, a result of the anti-uranium movement of the 1970s and 80s that saw students and workers on the streets refusing to let the government build uranium mines. Student activists have always been part of the fight against nuclear energy and weaponry in Australia and must continue it today.

Platform:

- That UMSU condemns the LNP's proposal to build nuclear power reactors in Australia.
- That UMSU rejects the viability and safety of all nuclear energy and by extension nuclear weaponry.
- That UMSU opposes the mining of Uranium and calls for it to be banned in all Australian states.
- That UMSU understands the creation of nuclear power reactors to be inextricably linked with a nation's ability to produce nuclear weaponry.

## 10.6. UMSU condemns Labor's amendments to the Fair Work Act as unserious

Preamble:

The Albanese government is bragging about its latest raft of amendments to the Fair Work Act.

Airtight legislation can provide a basis for unions to mount serious fights for better rights. Labor's amendments are anything but.

Australia has one of the most casualised workforces of any advanced capitalist country. This is a serious problem for workers, as the 'casual' classification dramatically reduces their rights. But this legislation offers no real steps forwards for casual workers. A section of Labor's new definition of "casual work" states: "An employee who has a regular pattern of work may still be a casual employee if there is no firm advance commitment to continuing and indefinite work". This is the exact argument that the High Court accepted in 2021 when it ruled that Robert Rossato, a truck driver in a coal mine, had to stay as a "casual" even though he'd been given a roster for work which specified every shift for the next 12 months. And now this is written into Labor's legislation.

There is a whole section on casual work but it offers only fluffy language. The substance beneath the surface has few clauses a union could seriously enforce.

This is typical of Labor's approach in government in general – on the surface they are for unions and workers, but beneath a thin surface, they're not.

It remains to be seen how all of the legislation will play out, but it does not bode well.

Platform:

That UMSU condemns Labor's amendments to the Fair Work Act as mostly rhetoric, offering no steps forward for the union movement.
