11.1. UMSU stands with climate activist Violet Coco against state repression

Preamble:

In April, climate activist Deanna 'Violet' Coco blocked a single lane of the Sydney Harbour Bridge for 25 minutes in protest against climate inaction.

Last week, Violet was handed down a 15 month prison sentence, with a minimum of 8 months, for participating in this action. She was refused bail while she lodges an appeal.

NSW Liberal Premier Dominic Perrotet said this decision was "pleasing to see" and warned of further repression for protestors who "want to put our way of life at risk".

This is an outrageous attack on the right to protest.

Politicians and the courts have spent years defending and aiding fossil fuel companies' right to make mega-profits from mining and burning fossil fuels. They know that this is leading to the destruction of the planet, and putting billions of people's "way of life" - and lives - at risk.

But when protestors like Violet demonstrate to draw attention to this they are given massive prison sentences by the courts using laws created by politicians who support the fossil fuel industry.

UMSU stands against this latest attack on the right to protest. Cases like Violet's normalise the creeping authoritarianism of governments who want to deal with the climate crisis by jailing those who protest against them.

Importantly, there have been snap rallies called across the country to stand in solidarity with Violet and defend the right to protest. Incoming UMSU Environment Officer Emma Dynes spoke at the Melbourne rally, saying "We need to keep fighting against the people creating this crisis... and the way that we need to do that is to fight against attacks on our civil liberties and get as many people out onto the streets"

Platform:

- 1. UMSU reaffirms its support for the right to protest as a basic civil liberty and democratic right.
- 2. UMSU stands against the latest attacks on the right to protest, including the NSW government's anti-protest laws but also the Victorian Labor government's criminalisation of anti-logging protestors.
- 3. UMSU expresses its solidarity with Violet Coco and gives her its full support in her appeal against the unjust NSW legal system

Action:

1. UMSU will publish a statement of solidarity with Violet on social media including the title and preamble of this motion.

Bella Beiraghi spoke to her moving rights, reiterated the preamble as several members of council had not received the updated agenda.

Speaking list opened for discussion.

Some members of Council raised concerns with areas of wording of the original motion.

Proposed Amendment from Kevin Li:

- 1. Remove the last sentence of the preamble from any UMSU releases that may result from this motion, we do not want to set the precedent of Having the appearance of OBs other than the president making statements that appears to have been endorsed by UMSU, especially when they were made outside of their role acting as UMSU council members.
- 2. Remove the condemnation of the Victorian government from the statement, the preamble makes a strong case for the condemnation of the NSW government, it neither mentions nor explains the condemnation of the Victorian government, the point is tacked on and unrelated.

This was not amenable to the mover or seconder.

Speaking list moved to discussion on the proposed amendment.

Those against of the amendment noted that they believed Office Bearers should be able to speak to matters such as the above. Also noted that the second proposed amendment remains relevant, as the Victorian Labour Government is also guilty of criminalisation of anti-loggers, and that there needs to be a unified front on holding all state governments accountable.

Alessandra proposed that perhaps Emma's statement be noted as coming from an Unimelb activist, rather than as coming from an UMSU representative, given that the President is constitutionally the UMSU spokesperson, or alternatively that Council votes on accepting Emma as the spokesperson on behalf of UMSU for this matter.

Proposed Amendment from Alessandra Soliven:

1. To amend the last sentence of the preamble from any UMSU releases that may result from this motion to include and identify Emma as a student activist at the Union.

Proposed Amendment from Emma Dynes:

1. Amend + add to preamble: This follows a generalised pattern In Victoria, the Daniel Andrews Labor government passed similarly anti-democratic laws aimed at anti-logging activists trying to prevent the destruction of native forests. The Sustainable Forests Timber Amendment Bill upped fines to \$21,000, jail sentences to 12 months and zones banning protest. In Tasmania, the Liberals tried for the fourth time to increase fines for individuals to \$12,975 and for organisations to \$103,800 and sentences of up to 18 months.
