10.2. SRN Motion

Preamble:

The Education (Academic) Office has been working to fulfil the obligations of the Student Representative Network (SRN) Policy since October 2022. This necessary process is due to the importance of the SRN in maintaining student advocacy across the University.

Requirements to launch applications within the guidelines of the policy whilst balancing requests by various University Committees are described in the Policy under Section 3, Procedure for Appointment of Students to Relevant Committees.

After launching the first round of applications, we were also unable to find enough applicants for Faculty-specific Committees. Some Faculties also faced the same issue from their application platform and reached out to the Office for broader recruitment.

Due to the urgency of filling these Committees before the year progresses further, it is imperative that we are able to open and close the second round of nominations in a timely manner. This would mean suspending Section 3.2.2(4), which requires applications to remain open for one month after the announcement date. As many committees have already held their first meetings for the year, it is crucial that we are able to attract and nominate appropriate candidates to represent UMSU and the broader student body.

Preamble:

The UMSU SASHWG is a group made up of student representatives dedicated to developing whole of union campaigns with regards to SASH at Unimelb. It also assesses and recommends changes/updates to UMSU policy and regulations concerning SASH and helps develop best practice in prevention of and response to instances of SASH on campus. As per UMSU's SASHWG Terms of Reference (see 4(a)(ii)), three voting members of Students' Council are to sit on this WG as appointed by resolution of Council. Given the need for us to hold a meeting of SASHWG ASAP, we need to open nominations so that we can run the WG with (hopefully) full membership. That being said, as SASHWG deals with sensitive and potentially retraumatising content, please be mindful of your personal safety and capacity before nominating. 10.4. UMSU endorses the Nation Day of Climate Action, Friday March 17

Preamble:

From searing heatwaves in North America and Europe to devastating floods in Pakistan and Nigeria, climate catastrophes are already mounting across the world.

This is unfolding in a world on average 1 degree hotter than the pre-industrial era. International scientific bodies predict that the existing climate policies will see warming rise to 2.5 degrees. That would exceed the already modest climate targets of the 2015 Paris Agreement and push us beyond the brink of an uninhabitable planet.

These accumulating climate disasters and wellspring of scientific research presaging the myriad effects of an even hotter planet demonstrate that the time to rapidly transition away from fossil fuels was yesterday. This is what governments internationally refuse to do on the scale and with the speed necessary.

The Australian government continues to be one of the worst offenders in this regard. Since signing the Paris Agreement in 2015, the Australian government has increased its fossil fuel subsidies by 48%.

The Albanese government, while boasting about its newly legislated emissions reductions targets as a huge advance on the low-bar set by the former Coalition government, is continuing the latter's deep commitment to expanding the fossil fuel industry. It is overseeing 114 new fossil fuel projects, including the Scarborough-Pluto gas project. That project alone will produce three times Australia's current annual carbon emissions across its lifetime.

The University of Melbourne adopts a similar duplicity to the Labor government. While it celebrates its sustainability programs and climate research, the University continues to bolster the fossil fuel industry through its partnerships with mining companies like Rio Tinto and weapons manufacturing companies like Lockheed Martin, alongside its large investments in fossil fuel companies. When met with student criticism of these partnerships, University of Melbourne representatives have been actively dismissive of concerns and reiterated a commitment to ongoing collaboration with fossil fuels companies.

To fend off the worst effects of the climate crises that are already here and fight for a liveable planet, we cannot look to governments and big businesses that march in lockstep with the fossil fuel companies responsible for climate destruction. We instead need a sustained movement from below capable of forcing radical change.

The political crisis fuelled by the protests against the Morrison government during the bushfire crisis of 2019-2020 offers a glimpse of the kind of defiant, mass movement needed to demand climate justice. The National Day of Action slated for 17 March is an important step towards building such a movement.

This National Day of Action (NDA) will be a day of coordinated protests for university students and young people across the country, organised by the National Union of Students (NUS). Student delegates across political factions committed to supporting the NDA at the National Conference of NUS last December.

The UMSU Environment Department will focus its attention in early semester one on building the NDA, which in Melbourne will involve a protest outside the State Library of Victoria at 2pm. We will be holding regular information stalls and activist meetings on campus to encourage as many students as possible to contribute towards the NDA in whatever capacity they can.

An accessible rally route will be published in advance. Covid safe measures and mask wearing will be encouraged.

Action:

- UMSU endorses the National Day of Action earmarked for Friday 17 March 2023, including its Melbourne-based component - a protest meeting outside the State Library of Victoria, at 2pm
- UMSU endorses the University of Melbourne student contingent to the National Day of Action to be organised by the UMSU Enviro department in collaboration with other UMSU departments supportive of climate activism.

• UMSU commits to promoting the National Day of Action, including the climate rally in Melbourne, in its newsletter and social media platforms.

Kimmy spoke to moving rights. Gave context due to lack of preamble: this was discussed with the C&S committee, and they agreed and believe there is not yet the staffing support available or budgeted in order to handle the administrative burden of processing new club applications. Explained the new club application process and extent of admin and workload required.

Ngaire spoke to seconding rights. Noted that to maintain a safe and accessible workplace and avoid burnout among staff and OBs, that Council should uphold this motion.

Phoebe Churches spoke to budget points – clarified that the commitment to providing full support to the workforce planning in areas such as C&S is there,

however the financial standing of UMSU is currently unable to support additional staff. Awaiting ideally good news in the true up, which may provide a windfall in supporting workforce planning. Currently there are other strategies in place to support the department. Suggested that this decision be reviewed once there is better financial support available.

Mohamed proposed amendment to the motion: To close clubs applications for Semester 1 and reopen them for semester 2 pending administrative and staffing support. This was amenable to the mover.

10.6. Iran protests solidarity motion

Preamble:

Mass protests exploded in Iran last September after 22-year-old Jina (Mahsa) Amini was brutally murdered by the state's "morality police". The young Kurdish woman's murder ignited a nationwide revolt against the Iranian regime. Workers, students, the young and the old - every section of society took to the streets demanding justice for Jina. Nationwide protests soon began calling for the downfall of the Islamic Republic, demanding "women, life, freedom."

Universities are the beating heart of resistance. Sit-ins and occupations continue on campuses around the country. Students have defied the state's dictate of gender segregation and beaten back security forces' attempts to smash their protests. Women and ethnic minorities lead crowds of thousands on the street chanting slogans of solidarity - "from Kurdistan to Tehran" and "we are all Mahsa". Workers across industries including oil, transport, sugarcane, construction, healthcare and education, have launched strike action and joined the nationwide rebellion.

This heroic mass uprising has mounted the deepest revolt in Iran since the 1979 Revolution. Protests have been met with the iron fist of the Iranian state, hell- bent on crushing the resistance. There have been over 18,000 recorded arrests and over 400 recorded deaths - yet the real number is likely to be much higher. Over the last month the regime has begun executing protestors on charges of 'waging war against god'.

Despite the onslaught of state repression, the rebellion in Iran continues today. Struggles like this are the answer to the immense injustices of the system. They should be met with internationalist solidarity from students and trade unions from across the world. Not only out of moral imperative, but because while Iranian women, workers and students remain oppressed and exploited, we will too.

Motion:

UMSU stands in solidarity with the nationwide rebellion in Iran, recognising it as a popular democratic struggle of the masses of ordinary Iranians against the regime. We stand in solidarity with the efforts of student activists on campuses and condemn the state's brutal repression of protests. UMSU also stands in solidarity with worker's across the country who are organising in independent trade unions and striking to fight for their demands. The struggle in Iran is an inspiration to everyone fighting against exploitation and oppression and we champion their demand for "women, life, freedom!"
