3.1. STG Regulation and Constitution

The regulations and the model constitution are both taken as read. The chair raised the opportunity for questions.

Evelyn raised a concern regarding the wording of Section 3(a), concerned about the last line of the proposed regulation, proposing that the line has a counter-purpose.

M. Bartolomeo explained the justification behind the choice of wording and the composition of the paragraph. Proposed an amendment for the wording which may be more amenable to the councilors.

P. Churches further clarifies the purpose and composition of the clause and concurs that an amendment could be moved to change the language.

Amendment 1 - Proposing the addition of a clause to the STG model constitution.

Section 4(c): Associate membership will be open to any other persons who subscribe to the aims of the STG.

Amendment 2 - Proposing an amendment to the STG model constitution.

Section 7(g): quorum will be defined as a minimum of 15 University of Melbourne student members of 2/3rds of the total membership base, whichever is the smaller

Amendment 3 – Proposing an amendment to the STG Affiliation Regulations to change the wording of the final sentence.

Section 3(a): [...] A STG may not expel a member for any reason which may constitute unlawful discrimination.
