- We follow the UMSU International Regulations, and the UMSU International Electoral Regulations, in administering the election
- We don't set the Regulations
- They are both on the website. Read them

Positions for election

- There are 20 positions, to which 33 people will be elected
- Website has full list

Eligibility



Main rules:

- International students can run for anything
- You can only win **one** position
- You can't run for more than two positions

Eligibility




- More specific rules:
 - Planning to go on exchange? → Not eligible
 - Course expected completion date before end of term? → Not eligible
 - Graduate positions → must be graduate student
- See Regulations for full details
 - Including eligibility for NZ citizens/Aust PRs/Aust citizens

Nomination form



There are five pages:

- 1. Position you're applying for
 - Submit form multiple times for multiple positions
 - Overall maximum of two
- 2. Your personal details
- 3. Policy statement & photo
- 4. Name and details of a **nominator** and **seconder**
- 5. Declaration of eligibility

Nominator and seconder




- You must have a nominator and seconder
 - Must be an international student who is not a candidate
- They'll be sent an email to confirm consent to nominate/second you
- They must follow the instructions in the email by 5pm 24th April
- Your responsibility to ask them to do this

Confirm you seconded a candidate Dear Stephen Luntz, The University of Melbourne Student Union (UMSU) International elections require all candidates be nominated and seconded by another student. - New this year; optional
- Submitted with your nomination
 - Need to update? Email us but **before** close of nominations
- Will be included on ballot and published on website



Policy statement and photo

- Photo: must be clear, recent and faithful photo of you
- Policy statement: max 250 words
- We print Them exactly as recieved withot fixing grammer, spalling, or fact checking
- Over 250 words? If you do this, then [slide truncated]

Policy speech session



- An UMSU International election institution
- All candidates required to attend
- Date and time to be confirmed
- Executive and Director positions present speeches
- All candidates participate in Q&A

Voting



- All international students eligible to vote
- Everyone eligible will be sent an email at 9am Monday 6th
 May
 - may take a few hours to arrive
 - link is to BigPulse secure voting platform
 - we will send all voters two reminder emails (Wed and Fri)
- Voting will be preferential (number 1, 2, 3, etc)

Results



- Voting closes 5pm Friday 10th May
 - The platform will not allow votes after this
- Expect to have interim results over the weekend (likely Friday night)
- One academic day for appeals/recount requests

Secrecy



- **IMPORTANT**: This is a secret ballot
- Voting links are unique to each student and can't be forwarded
- You must not observe anyone in the act of voting

Campaigning

- Campaigning is convincing people to vote for you (regardless of how it's done: in person, online, to your friends, or to the world at large)
- There are a number of rules that you must follow



- Who can campaign?
 - Candidates can campaign
 - Each candidate can have up to two student campaign representatives
 - You are responsible for what they do, so only pick people you trust
 - You must tell us who they are (there will be a form), and we will publish the list



- When can you campaign?
 - Only during election week



- Registration of material
 - All publicity materials must be **registered** with the Returning Officer before they can be distributed, posted, or made available to students
 - Register by emailing us with a copy
 - If unsure, wait for us to reply
- This includes posters, pamphlets, social media pages & status updates



- Group campaigning
 - You cannot form a group, ticket, team or party and campaign together
 - You can campaign for yourself, but not others





- Approaching students on campus
 - You can approach students and tell them about the election and yourself, and why they should vote for you
 - You cannot help a student vote
 - You cannot stand near a student, or engage with them in any way, while they are voting



- Approaching students on campus
 - Being near a student while voting violates the secrecy of the ballot and we take it very seriously
 - If a student has their phone out while you are telling them what to do it is **very obvious** to us you are breaking this rule

Campaigning: other rules



- Bulk emails, texts, use of mailing lists and direct messages are not permitted
- Bribery, including handing out anything (e.g. lollies) with your pamphlets is **not** permitted
- You can't use the UMSU International logo or motto on your material
- Any conduct that is dishonest, deceptive or misleading is prohibited
- Using resources of the University or UMSU (except those generally accessible to students) is **not** permitted

Campaigning: penalties



- If a complaint is made, or we discover a breach of the rules, we determine a penalty.
- Examples include:
 - A warning
 - Suspending you from campaigning, including requiring you to take down social media
 - Disabling your candidate statement from appear for a period of time
 - Disqualifying you from the election
 - Referral to the UMSU Electoral Tribunal for further action
 - Referral to the University under their Student Misconduct Policy
