Clubs and Societies: Gavin Wayne asked if Students' Council had any feelings or opinions on the Grievance Tribunals' ruling against Students' Council.

Kayley Cuzzubbo indicated that the C&S regulations were there for a reason, and that the department had to have standards. No one from Council turned up to the Grievance Tribunal to defend their actions or reason that the disaffiliation should've been overturned.

Numerous councillors said that the notice of the Grievance did not expressly inform them that they had to come to the meeting. Yasmine indicated that the tribunal members had requested and checked the wording of the notice.

8.5 The Mishandling of Farrago's Reporting on the Respect. Now. Always. Campaign

- 1. Last week, both Yan Zhuang, the president of UMSU, and Hannah Billett, Women's Officer, approached the Media Officers to suggest that an article be published on UMSU's refusal to participate in the University's *R espect, Now, Always* campaign. 2. The Media Officers agreed to commission an article as they deemed this to be in the interest of the student population.
- 3. On Thursday, Hannah Billett undertook an interview with *F arrago* reporter, Ashleigh Barraclough. For this interview, Hannah was given the permission of Yan (who is the spokesperson of UMSU) to speak on the record for UMSU. 4. An article was written up over the weekend by Ashleigh Barraclough and was scheduled to be published at 12pm on Monday 31 July.
- 5. Ashleigh was asked by Yan to see Hannah's statements so she could sign off on them. Ashleigh obliged. 6. At 9pm on Sunday night, Yan Zhuang sent a message to Alexandra Alvaro saying that herself and Hannah had 'fucked up' and that the comments were 'not constructive at this stage'. Yan then retracted her permission for Hannah to be a spokesperson for UMSU and requested that the article not be published. 7. On Monday, Mary Ntalianis contacted the General Secretary, Yasmine Luu, to inform her of the situation and to ask if Yasmine would be able to approve the publication of the piece. 8. Yasmine Luu said that she was unable to approve the article being published as Yan's permission for Hannah to be a spokesperson for UMSU had been retracted. 9. As a result of this, the Media Officers decided not to publish the article. 10. At around 3pm that day, Hannah Billet sent a message to Alexandra to 'retract' her comments.

The Media Department is not the PR body of the Student Union. The President (and

other Office Bearers) cannot tell the Media Officers to pull an article based on the fact that its content is 'not constructive' for UMSU's PR strategy.

We believe the President overstepped their role in the following ways; Yan should not have asked Ashleigh, a reporter, to see Hannah's statements. Sources are not to be involved in the writing process and if Yan wanted to check Hannah's statements, she should have had that conversation with Hannah. These sorts of actions put the integrity of our reporting at risk. Yan cannot revoke permission for an Officer Bearer to speak on behalf of UMSU after the fact. It is the responsibility of the President and the Office Bearers to ensure that all media statements are correct and approved by appropriate channels before they are given on the record. Additionally, it is standard media practice that once a quote or statement is given on the record, it cannot be taken off the record.

The General Secretary also overstepped by giving the Media Office the impression that it was not within its right to publish without her permission.

This story deserved to go ahead with the original statements in place because it was of interest to the student body. Students deserve to know when the University is being dubious or ineffective in its responsibility to keep students safe. If student reps believe that a campaign being run by the University is little more than a 'pre-emptive PR exercise' (as Hannah said in her statement), then students should know that. After the quotes were retracted by Hannah, more were sent through. They lacked any newsworthiness and could not be formulated into a story of similar quality.

The Media Officers believe that the lack of autonomy afforded to UMSU Office Bearers in communicating to *F arrago* issues and happenings that are specific to their departments is in part, causing situations like this to arise.

#### **Motions**

 That UMSU Regulations for Student Representatives be amended to allow Office Bearers to act as spokespeople for the organisation without going through the President when giving statements to F arrago – i.e. Farrago would be an exception to the current policy; 2. That Students' Council affirm that statements given on the record to the Media Department cannot be taken off record once given, in line with the Newspaper Policy and standard journalistic practice, and that the Media Department cannot be compelled to pull statements due to dissatisfaction with their content; and

3. That Students' Council affirm, in accordance with the Newspaper Policy, that the Media Department is independent and is responsible for its editorial content, that the General Secretary is publisher in name only, and that Office Bearers cannot exercise editorial control over the content of the Media Department.

Gavin Wayne asked that the discussion on the motions be split as they are all quite different.

Yasmine Luu clarified that Council could not change the Procedures for Student Reps regulation during the meeting due to notice requirements. The meeting can direct changes to be drafted instead.

Gavin asked if all OB reports in Farrago were checked by the President. Yan said she did not do this.

Mary Ntalianis stated that OBs are currently unable to make a statement on behalf of UMSU or their department without going through the UMSU Spokesperson (The president).

Request to amend motion 1 to say "...act as spokespeople for their relevant departments without..." . This is amenable to the mover.

Lizzie Nicholson said that OBs were elected to speak for their constituency, and they should be able to speak freely. She said the current situation was confusing and needs to be made clearer.

More discussion on the potential issues if more than one person could act as the spokesperson for UMSU.

Mary said that if there was a 'rogue OB" that gave media statements, Media wouldn't publish them.

Yan said that it would be good to get clarity on the issue – the University rang her after hearing of this article and asked her if that was her opinion, or the opinion of UMSU's or the opinion of the Women's Department, and there was general confusion.

Molly Willmott said that Farrago was a separate entity to UMSU and should be able to have free access to the OBs.

Yasmine stated that she was initially completely unaware of the article, until Mary rang her 30 minutes before it needed to be published. Yas received advice that she as publisher could and should pull the article. Yas said that she agreed that this was overstepping and apologized to the Media Officers. She stated that she had no

communication from the UMSU President during this issue.

Multiple councillors and OBs suggested that the current situation and regulation was ambiguous and needed clarification.

Gavin Wayne and Daniel Beratis called for a Working Group to sort out the current standing and review the Regulations for Student Representatives.

Gavin indicated that he believed that the UMSU President should be able to rescind spokesperson rights to a delegated spokesperson in cases like this, but that the President should also not be able to take things off the record – so the quote would remain, but not as an UMSU opinion. He suggested that if the spokesperson power is delegated that it be delegated very clearly to avoid issues like this.

Lucy Turton said that that was a "fascist idea" and that it's "fucked up that a president can control what is said by the student magazine", and suggested that the issue was a freedom of press issue.

Gavin indicated that his idea was that the quotes could not be controlled, that they would still exist in print, but not as UMSUs whole of organization statement.

Mary said that Yan going to the reporter to see the article before talking to the Farrago Editors about it was very unprofessional.

Alice Smith indicated that she believed both statements should exist.

Yan said she took full responsibility regarding delegating spokesperson rights without clear indications on what could be talked about. She said it was never her intention to prevent OBs from stating positions and silencing them. She stated that she had a discussion with Hannah over Facebook and they both thought the statements were inappropriate.

Mary said that Farrago was not a PR group for UMSU, and that their publishing schedule doesn't exist for the Presidents' personal PR strategy. She said the fact that Yan asked for it to be removed takes away the integrity of things being on the record.

As the 30 minutes had elapsed since loosing quorum, the meeting closed. Many Councilors continued the above discussion informally after this time.
