#### 9. Motions on Notice

#### 9.1 Bar Refurbishment

Preamble: Earlier this year, Students' Council moved \$15,000 from Contingency to be put towards works associated with the creation of an UMSU Bar in the Level 1 space. So far, this money has only been spent on adding some second-hand couches to the space (\$80) and prize money to incentivise the student design competition (\$1000 over first, second and third), however the real costly works are yet to commence.

Aesthetic improvements are high on our list of priorities for the space, as this was a recurring theme that came out of the UMSU Bar Survey. I contacted the University's Campus Services / Infrastructure Services department to ask for their opinion on some of the basic costs associated with a superficial revamp of the space (in the hope that they might also offer me some money; they have informally offered to check if they have money to spare Campus Services Backlog Maintenance Budget). This initial assessment indicated that even a re-paint of the space will cost in the vicinity of \$10,000-\$15,000.

UMSU is currently running a design competition to garner ideas for the space, the best elements of which (that we can afford) will be implemented in December by contractors. We will be looking to pay labourers fairly for their time, and at this stage \$15,000 isn't going to take us very far. I will be continuing to seek extra funding from alternative sources in the University and MUSUL on top of this money.

### 9.2 Common Equipment - Camera & GoPro

Preamble: Likewise, there has been suggested benefit from the purchase of a camera and GoPro to allow Departments and Programs to better document their activities, and increasing engagement and promotion of their events. The Media Office previously

possessed a camera, which was lost by another department at some point in 2014. There will need to be a policy and process set up for the check out and check in of these devices.

Sarah Xia requested that the Speaking List be read.

Caleb said that he was working on a policy regarding how to use and borrow such equipment for the Media Department.

Sarah said that she did not think we needed a GoPro, and that Media Department would have the equipment mentioned in the aforementioned policy.

Patrick Clearwater said that there was a deficit of high quality photos, and suggested an amendment to include insurance to allay fears of equipment being lost or stolen. This was amenable to Rachel and Itsi.

Motion: To move \$2500 from Whole of Union for the purchase of a communal DSLR Camera and GoPro and insurance to cover both items.

Lachlan McCall said that he respectfully disagrees with Rachel's justification for why we need a GoPro. He said that we could use camera phones to document events.

Rachel said that camera phones are good, but that we are missing archival documentation. People tend to delete items from their phone and not download them for achieving.

Shanley said that the lack of archive materials is a product of laziness, not a lack of resources.

Nellie said that it is not unreasonable to invest in resources and that common resources are good.

Sarah said that the DSLR should be able to take videos.

Stephen Smith said that it is not unreasonable for a \$5M organisation to spend a relatively insignificant amount on a camera and GoPro to record its events and achievements.

Daniel Sullivan said that these sorts of resources have been good for Fossil Free MU.

Rachel said that UMSU offers vast activities, so a variety of apparatus to record this would be good – the GoPro offered greater flexibility to record events where a DSLR may not.

#### 9.6 Monash wall

Preamble: For too long the University of Melbourne has been overrun. We've been overrun by all kinds of people from Monash, and I'm here to say *enough*. I have no doubt that there are some good people from Monash, no doubt whatsoever. Some of my friends are from Monash. But there are also criminals, thugs and generally bad people coming here from Monash. They're a burden on our University, a burden on our way of life. I'll tell you what I'm gonna do. I'm gonna build a wall between here and Monash, *and I'm gonna make the MSA pay for it!* Believe me, I will make Unimelb great again!

Motion: That the Council endorses in-principle the construction of a wall between the University of Melbourne's Parkville campus and Monash University's Clayton Campus.

That the Council also endorses in-principle the intention that the Monash Student Association pay for the construction of this wall, as well as any additional expenses which may arise as a direct result of construction.

Stephen Smith raised a Point of Order, saying that this was not allowable within the Standing Orders.

Martin Ditmann dismissed this, and cited that a Point of Order needed to refer to a specific clause within the Standing Orders.

8.1 C&S Regulations changes

#### Rationale

The C&S Regulations are silent on dispute resolution, except for mediation of internal administrative disputes in club committees. As the awareness and identification of bullying and harassment has become more widespread more complaints have been made of this nature, which are largely dealt with in an *ad hoc* manner, and the question of participation rights has been raised (i.e. can a member be suspended?). Thus we have sought to develop a departmental protocol to govern with the proper support and administration of due process.

## Regulation 9. Grievance Procedure (new Regulation)

## 9.1 Attempt to resolve between parties

Should any grievance between clubs, or individuals within clubs, or between a University of Melbourne student and a club arise, parties shall be invited to meet and resolve the grievance within 21 days of notification.

### 9.2 Failure to resolve

Should parties subject to the grievance fail to determine a resolution within 21 days, or earlier should a club or individual request it, Clubs & Societies shall organise mediation to occur between the parties.

## 9.3 Appointment of Mediator

The Clubs & Societies Officer/s or their nominated representative shall appoint a certified mediator to facilitate mediation. The mediator shall not be a student of the University of Melbourne or have been so within the past 5 years.

### 9.4 Support during mediation

An individual may bring a support person to mediation. Any parties to the mediation who identify as a Wom\*n, Queer, Indigenous, Trans\*, or as a Student with Disabilities are particularly encouraged to bring a support person from a relevant constituency.

#### 9.5 Timeline for mediation

A mediator shall be appointed within 5 days of Clubs and Societies receiving a request for mediation (Regulation 9.2). It is then up to the mediator and the parties subject to the mediation to determine a time to convene the mediation.

## 9.6 Right to privacy during mediation

If any individuals subject to mediation do not wish to meet face-to-face with any other parties subject to the mediation, the mediator must facilitate an alternative mediation process.

## 9.7 Members' sanctioned during mediation

If the parties involved fail to resolve the grievance in the process outlined in R9.1 and mediation is sought, all parties subject to the subsequent mediation shall have certain rights as a member of the club suspended until an outcome is determined through mediation, as defined in R9.8.

### 9.8 Rights suspended through mediation

Rights suspended under R9.7 includes attendance at club events, with the exception of attending general meetings of the club, and committee and executive meetings of the club and exercising their ability to vote and run in elections. Members subject to mediation will still have access to minutes from club meetings and other documents that they would otherwise have access to, as well as the ability to call for an SGM and to petition to expel a member from the club.

## **Club Standard Constitution (new clause)**

17. Any grievance that arises between a club and UMSU, a club member and another club member, or a club member and another University of Melbourne student is subject to the grievance procedure outlined in the UMSU Clubs & Societies Regulations. If the parties subject to a grievance are unable to meet and discuss the grievance and determine a resolution within 21 academic days, the UMSU Clubs & Societies Officer/s or their nominated representative shall appoint a mediator to facilitate mediation. Parties subject to mediation will have certain rights as members of the club suspended until mediation is completed.

Renumber remainder of Std Constitution to include 17 and increase total clauses from 22 to 23.

Stephen spoke to his moving rights, outlining that the proposal in item 8.2 had previously been rejected by Students' Council, which prompted consultation with the relevant Councillors and that their concerns had been addressed.

Nellie said that the Safety in Clubs changes are important, and that a grievance procedure was also important on a bigger scale for UMSU.

Martin clarified that we are voting first on the miscellaneous amendments, not the Safety in Clubs changes.

Patrick asked about the use of "association" for clubs, and why this was being changed.

Stephen referred this to Justin Bare. Justin said that "Association" has a specific meaning within the Constitution and the Act.

Motion 14: To adopt the miscellaneous proposed amendments to the C&S Regulations concerning elections, mergers, term of office, and associations.

8.2 Safety in Clubs Regulations Changes & Referring Grievances in C&S

Sarah Xia said that mostly she welcomed the amendments since they were last presented, but that during consultation she was told it was "inappropriate" to include "people of colour" in Regulation 9.4.

She moved an amendment so that 9.4 read:

An individual may bring a support person to mediation. Any party identifying as coming from a disadvantaged or minority background is particularly encouraged to bring a support person from a relevant constituency.

Stephen said that he and C&S Department had been misrepresented. He said that it was not the role of the C&S Regulations to define "People of Colour" and that the restricted constituencies listed in the proposed Regulations were already defined terms within the UMSU Constitution.

Further, he said that given the repeated concern from the Councillor, that he is amenable to her amendment. Itsi was also amenable.

Andrea Bozic moved an amendment to include in 9.4:

That support person may not be involved in the issue being mediated.

This was amenable to Stephen and Itsi.

Motion 15: To adopt the proposed amendments to the C&S Regulations concerning Safety in Clubs and to adopt the Referring Grievances in C&S policy, as recommended by the C&S Committee.

#### 10. Motions Without Notice

#### 10.1 NUS National Conference Grants

#### Preamble:

The National Union of Students is the peak body for Australian university students, and its annual national conference will be held from between the 7<sup>th</sup> and the 11<sup>th</sup> of December at Mannix College, Monash University Clayton. NUS National Conference (NatCon) is the forum in which all policy, regulation and constitutional changes to the NUS are debated and adopted, and as such it is important that as many students as possible are able to be involved in this process. Unfortunately, the registration cost for students wishing to attend NatCon as unofficial observers is \$200, which presents a barrier to many.

As a number of concerns about NUS have been raised by UMSU Students' Councillors, Office Bearers and other interested students this year, suggesting a strong interest in pursuing reforms, it is important that UMSU facilitates greater engagement of its members with NUS in order to ensure the organisation is adequately representing students of this university. It is also important that students are able to be kept informed about NUS and its purpose and policies through student media to facilitate greater engagement.

#### Motion:

## That Students' Council:

- -Approves the expenditure of \$1000 from Whole of Union to partially cover the registration cost of Caleb Triscari (incoming Media Officer) to attend NUS NatCon as a Media Observer (\$1000), acknowledging that Caleb will repay UMSU \$500.
- -Approves the expenditure of \$1000 from the Education Department budget line 'Campaigns, Special Projects and Events', and \$1000 from the Students' Council budget line 'Student Grants and Initiatives', to subsidise all or part of the registration costs for students to attend NatCon as unofficial observers
- -Empowers the President, General Secretary and Education Officers to develop a selection process to allocate grants to applicants wishing to attend NatCon based primarily on financial need
- -Calls upon the Office Bearers listed above to ensure that the availability of grants is adequately publicised to allow access to as many students as possible

Mover: Hana Dalton Seconder: Conor Serong

Hana and Conor spoke to their moving rights. They both said that it was important to break down the financial barriers for students attending NUS National Conference.

Stephen Smith asked how this was going to be promoted – and whether it was just targeted at students already involved or whether it would include students not already involved. Hana said that promotion would be both internally and externally.

Pat Dollard said that it was important to have reports back to UMSU.

Rachel said that there are barriers in place for "regular students" to engage with NUS, and that these barriers exist beyond financial barriers.

Shanley reiterated the importance for students to be able to attend National Conference.

Steven Connolly said that UMSU had its own problems with inclusivity.

Itsi said that \$1,000 seems a lot of money for a media observer and that there had to be other options – given it was in Melbourne.

Caleb said that he is going to repay \$500 to UMSU after the fact, and that he could not report on the events of NUS if he wasn't there. The late nights are difficult for him to get home from.

Rachel said that late nights were yet another barrier to students engaging with NUS – however, it was unfair for Caleb to have access to greater resources simply because he was the Media Officer.

Lachlan McCall suggested that we could pay \$200 and approve some extra money for taxis for Caleb.

Caleb moved an amendment that he repay UMSU \$800 of the costs, which was amenable to Hana and Conor.

Hana said that arguing about the problems of NUS here does not address the problems, and that we need to be a part of the solution.

Rachel moved an amendment to include "Directs that UMSU delegates make themselves available for students to raise concerns," which was amenable to Hana and Conor.

Sarah Xia voiced concerns about delegates' personal details being published online, to which Rachel said not to put yourself forward for a student representative role if you did not want to talk to students.

Sarah called for a Point of Order about whether other speakers could interrupt and speak over the top of the person with the call.

Martin outlined that speakers need to be respected while they have the call.

Further discussion about whether we have the ability to direct delegates ensued. Rachel said that given we pay affiliation and pay for their registration that we should have the power to direct them engage with students.

Stephen asked whether money for Caleb might be found in the Media budget, if it is so vital to have a reporter there. Martin said that all remaining money had been accounted for.

Steven Connolly proposed an amendment to return to the original motion regarding Caleb's repayment to UMSU being only \$500, which was not amenable to Hana or Conor.

Foreshadowed motion 2: That the motion be amended so that Caleb is only required to repay \$500 to UMSU.

Mover: Steven Connolly Seconder: Lachlan Gell

Pat Dollard urges delegates to consider the concerns of students.

Hana moved an amendment to the motion that money be paid upon receipt of a report from observers, which was withdrawn following discussion around the practicalities of this.

Hana and Conor acknowledged that a report would still be required, similar to the grants system for NUS Education Conference.

Steven's foreshadowed motion was voted on first.

Motion 16: That the motion be amended so that Caleb is only required to repay \$500 to UMSU.

Mover: Steven Connolly Seconder: Lachlan Gell

#### Motion 17: That Students' Council:

### 10.3 MUSUL Tenancy Issues

## Preamble:

The UMSU Legal Service has received a number of notifications from students employed by various Union House tenants that they are not paying their employees the award or above award wage for the work in breach of the relevant legislation. This has serious financial repercussions for those employees, many of whom are students at this University. It also has serious reputational consequences for UMSU who may be construed as responsible for the unlawful conduct. All Union House tenants are required to sign lease agreements with MUSUL to the effect that they will pay and support their staff the appropriate entitlements required by law. It is an embarrassment that an organisation such as MUSUL allows its tenants to disregard this integral part of the lease agreement and in doing so is complicit in the malfeasance. UMSU has made various attempts to have MUSUL enforce the contractual obligations of its tenants under their commercial lease, however to date MUSUL has failed to take any action to rectify the situation. UMSU is committed to supporting students and ensuring their rights and entitlements are honoured. As such and this is a situation that can no longer be ignored. As well as asking MUSUL to provide details of its proposed actions to

rectify this situation UMSU should request that MUSUL immediately implement measures to audit and accredit tenants who comply with their legal obligations and sanction those who are acting unlawfully or who refuse to evidence compliance. UMSU should consider further action including a comprehensive campaign around rights at work as well as the potential of highlighting businesses that are doing the right thing with stickers and encouragement for students to patron these businesses rather than those not fulfilling required legislation.

Motion: That Students' Council calls upon MUSUL to outline the practical steps that they will take to address the issues with Union House tenants not paying minimum wage or providing adequate workplace conditions, as required by law.

Andrea proposed amending the motion to include "encourages UMSU to run an awareness campaign."

Steven Connolly said that we should leave it as is.
