Ambrose Berlin: The legal advice they received was sound. There was no harassment or intimidation, it was just heated

Christopher Melenhorst: The Clubs and Societies regulations are clear, thus legal advice is not correct. Memberships have to be reapplied for at the start of the year

Chris Kounelis: Yes membership renewal used to be the case, but must be subordinate to the Clubs and Societies regulations

Catriona Smith: Member list must be taken otherwise AGM is not valid

Harry Black: Need to work out what to do to ensure this doesn't happen again

Ambrose Berlin: Doubt over the result must be shown for the AGM to be deemed invalid

Jordan Tochner: Means of voting was not valid

Catriona Smith: Whole AGM is invalid

Nancy Ciara Griffiths: This is a breach of the Code of Conduct and they created an unsafe environment

Chris Kounelis: Most business of the AGM was not done

Ambrose Berlin: If anyone's speaking rights were infringed it was ours, the motion of dissent in the chair was disregarded

Jordan Tochner: Reminder to discuss validity of the AGM, not who created the problem

Catriona Smith: Non-members were voting, other matters are not relevant

Ezra Bangun: It is the club's problem if they are unable to hold a valid AGM
